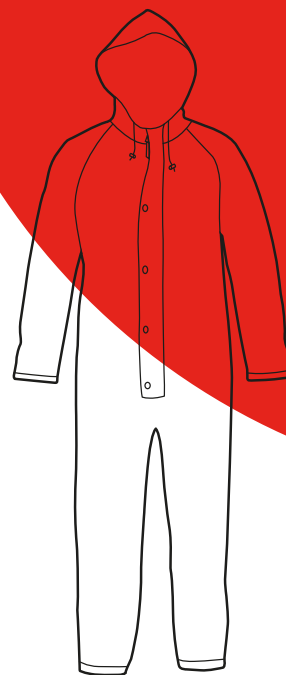

CLARIFICATION OF PICTOGRAMS

EN 343:2003+A1:2007 Protective clothing against rain

The EN 343:2003 standard specifies the requirements and test methods for clothing materials and seams which protect against precipitation (rain and snow), fog and ground humidity. For workwear that complies with the EN 343:2003 standard, water penetration resistance and water vapour permeability are of the greatest importance. These parameters are always stated next to the pictogram. The seams are watertight finished in accordance with the highest class.

EN 343:2003+A1:2007



X = Class of water penetration resistance, ranging from class 1 to 3 (see label for correct class)

Y = Class of water vapour permeability, ranging from class 1 to 3 (see label for the right class)

STORAGE CONDITIONS

The clothing should be kept in a clean, cool and dry place and not kept compressed in its original packaging. Do not expose the clothing to direct sunlight. Never store the clothing wet, always hang it to dry first. Make sure that the packaging and the garment are not damaged during shipping.
