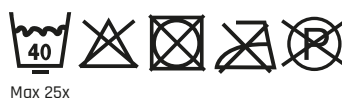

CLARIFICATION OF PICTOGRAMS

EN ISO 20471:2013+A1:2016 High visibility warning clothing

The EN ISO 20471:2013 standard specifies the requirements for clothing that aims to visually emphasise the presence of the user to make him stand out more in dangerous situations, both day and night.

X = class of the fluorescent reflective surface, ranging from 1 to 3 (see label for the right class)

	Class 1	Class 2	Class 3
Fluorescent material	0.14 m ²	0.50 m ²	0.80 m ²
Reflective material (required length for 50 mm-wide strips)	0.10 m ² (2 m)	0.13 m ² (2.6 m)	0.20 m ² (4 m)

The number next to the pictogram indicates under which class the article falls. This depends on the minimum amount of fluorescent and reflective material used.

Note! The reflective surface of class 1 clothing may not be provided with an overprint.

STORAGE CONDITIONS

The clothing should be kept in a clean, cool and dry place and not kept compressed in its original packaging. Do not expose the clothing to direct sunlight. Never store the clothing wet, always hang it to dry first.
