

STORAGE, MAINTENANCE AND CLEANING

When the helmet is not being used or during transport, please store the helmet in a robust and suitable container to prevent exposure to direct sunlight. The helmet must also be kept away from chemical and abrasive substances and you must take care to prevent any damage through physical contact with other (hard) materials. Safety helmets are not to be stored on the rear shelf of a vehicle. The helmet can be cleaned with warm water and soap and a soft cloth. Do not use any abrasive substances or solvents to clean the helmet and avoid storing the helmet in direct sunlight or in places where it may come into contact with solvents.
